2.The learned Counsel appearing for the petitioners would submit that based on the complaint lodged by the second respondent, the FIR in Crime No.33 of 2014 had been registered for the offence under Sections 447, 379(NH) of IPC, against the petitioners. After completion of investigation, charge sheet has been filed before the learned Judicial Magistrate, Bodinayakanur, Theni District and the same was taken on file as C.C.No.23 of 2018.

3.The learned Additional Public Prosecutor appearing for the first respondent would submit that in this case, out of twelve witnesses, one witness had already been examined and the case was posted for examination of the remaining witnesses.
