ORDER

This criminal original petition has been filed seeking a direction to the learned Judicial Magistrate, Bodinayakanur, Theni District to dispose the C.C.No.65 of 2016, in a time frame fixed by this Court.

2.The learned Counsel appearing for the petitioners would submit that based on the complaint lodged by the second respondent, the FIR in Crime No.28 of 2015 had been registered for the offence under Sections 447, 294(b), 324 and 506(ii) of IPC, against the petitioners. After completion of investigation, charge sheet has been filed before the learned Judicial Magistrate, Bodinayakanur, Theni District and the same was taken on file as C.C.No.65 of 2016.

3.The learned Additional Public Prosecutor appearing for the first respondent would submit that in this case, there are totally eleven witnesses and the case is posted for issuance of fresh summons to LW1 to LW3.

4.Considering the fact that the case was pending from the year 2016 and that the case is pending for trial, this Court directs the learned Judicial
