2.The learned Counsel appearing for the petitioners would submit that based on the complaint lodged by the second respondent, the FIR in Crime No.11 of 2017 had been registered for the offence under Sections 448, 447, 342, 379, 506(ii) of IPC, against the petitioners. After completion of investigation, charge sheet has been filed before the learned Judicial Magistrate, Bodinayakanur, Theni District and the same was taken on file as C.C.No.24 of 2018.

3.The learned Additional Public Prosecutor appearing for the first respondent would submit that in this case, there are totally twelve witnesses and the case was posted for examination of LW1 to LW3.
