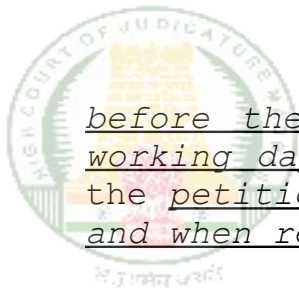

This Petition has been filed to relax the condition imposed in Crl.O.P(MD).No.19446 of 2022, dated 04.11.2022.

2.The learned counsel for the petitioners would submit that the petitioners have been complying with the conditions regularly and hence, he seeks for relaxation of the condition.

3.The learned Additional Public Prosecutor appearing for the respondent would submit that the petitioners have been complying with the conditions.

4.Considering the said submissions and nature of offence, the condition imposed by this Court in Crl.O.P(MD).No.19446 of 2022, is modified to the effect that the petitioners 1, 2 and 5 shall report



before the respondent police once in a month i.e., on the first working day of every month at 10.30 a.m., until further orders and the petitioners 3 and 4 shall report before the respondent police as and when required for interrogation, on receipt of summons.

5. With the above direction, this Criminal Miscellaneous Petition is ordered.
