3.The learned Additional Public Prosecutor appearing for the respondent would submit that the petitioners have been complying with the condition regularly and investigation has been completed and the final report has already been filed before the learned Judicial Magistrate No.I, Sivakasi and the case is pending committal in P.R.C.No.4 of 2022.

4.Considering the said submission, the condition imposed by this Court in Crl.O.P(MD).No.19429 of 2022, dated 03.11.2022 is modified to the effect that the petitioners shall report before the
