4.According to the petitioner, he made a representation dated 14.09.2022 to the respondents, raising serious objections to establish the TASMAL shop in the aforesaid place. Since the same has not been considered till date, this Writ Petition is filed.

5.The learned Government Pleader for the respondents 1 and 2 would submit that the representation of the petitioner dated 14.09.2022 would be considered on merits and necessary orders would be passed in accordance with law within a time frame.

6.In the light of the above, without going into the merits of the case, we are inclined to direct the 1st respondent to consider the representation of the petitioner dated 14.09.2022 and pass appropriate orders on its own merits and in
