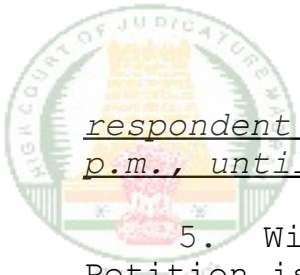

2. The learned counsel for the petitioner would submit that the petitioner has been complying with the conditions regularly and hence, he seeks for relaxation of the condition.

3. The learned Additional Public Prosecutor appearing for the respondent would submit that the petitioner has been complying with the conditions.

4. Considering the said submissions and nature of offence, the condition imposed by this Court in Crl.O.P(MD).No.15230 of 2022, is modified to the effect that the petitioner shall report before the



respondent police once in a week i.e., on every Saturday at 3.30 p.m., until further orders.
