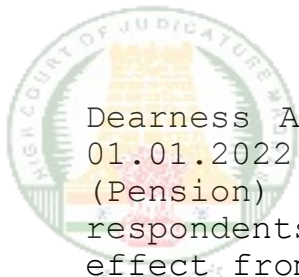

Ms.257 Finance (Pension) Department dated 18.08.2022 as ordered to other Government Pensioners by considering petitioners representation dated 06.12.2022 within the time frame as fixed by this Court.

ORDER:- This Petition coming on for hearing on this day and upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr. R.Vimalraj, Advocate for the Petitioner and of M/s.K.Christy Theboral, Additional Government Pleader for the respondents, this Court made the following order:

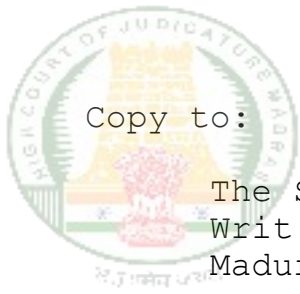
