Prayer in WP(MD). 2911/ 2017 :

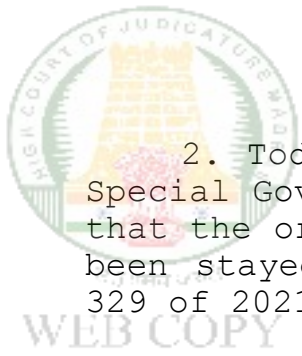
Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified mandamus calling for the records relating to the impugned proceedings issued by the 4th respondent District Educational Officer in O.Mu.No.8353/A2/2004 dated 24.12.2004, quash the same and further Direct the 4th respondent District Educational Officer to approve forthwith the appointment of the petitioner as Watchman w.e.f. 23.06.2004 to 06.02.2006 in the 5th respondent school namely T.C.K. Higher Secondary School, Padanthalumoodu, Kanyakumari District with all attendant benefits, including arrears of salary and allowances and pass such further or other suitable order / orders as this Hon'ble Court may deem fit and proper.
