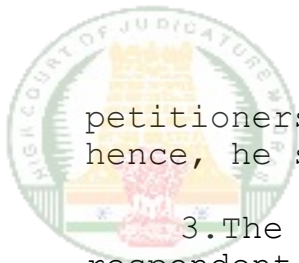
Prayer in CRL MP(MD).
