The petitioner has not placed any evidence to show that the aforesaid interim order passed by the Court has been informed to the respondent authority on or before 07.11.2015. In the absence of the said particulars placed before this Court, we are not inclined to accept the contention of the petitioner. Therefore, no contempt is made out and the respondents are discharged from the contempt proceedings.
