Prayer in CRL MP(MD). No.15923 of 2022:-

Criminal Miscellaneous Petition filed Under Section 482 of Cr.P.C. to extend the time in CrI.O.P(MD)No.19384/2022 dated 14.11.2022 for surrender before the Learned Special Judge for SC/ST (Prevention of Atrocities) Act/District and Sessions Judge (PCR Unit), Dindigul.

Prayer in CrI.O.P.(MD)No.19384 of 2022:-

Criminal Original Petition filed under Section 482 of Cr.P.C, praying to direct the Sessions Judge, Special Court for Exclusive Trial of Cases under SC/ST (POA), Act, 1989 Dindigul to consider the Petitioner's bail application on the same day of his surrender in Crime No.440 of 2022 on the file of the respondent Police.

Considering the submission made by the learned counsel appearing for the petitioners, the petitioners are granted 10 days extra time from the date of receipt of a copy of this order to surrender before the learned Sessions Judge, Special Court for Exclusive Trial of Cases under SC/ST (POA) Act, 1989, Dindigul. On such surrender, the learned Sessions Judge is directed to consider the same as per law."
