If the corporation authorities dispose of the petitioner's application, based on the same, the petitioner can very well approach the jurisdictional police authority. The police authority in turn will consider and pass appropriate order within a period of four weeks thereafter.

4. With this direction to the authorities to act on the petitioner's application, the Writ Petition is disposed of. No costs.
