Considering the submission made by the learned counsel appearing for the petitioners, the petitioners are granted 10 days extra time from the date of receipt of a copy of this order to surrender before the learned 3rd Additional District and Sessions Judge PCR Act Cases, Madurai. On such surrender, the learned Sessions Judge is directed to consider the same as per law."
