Prayer in CRL MP(MD). No.16068 of 2022:-

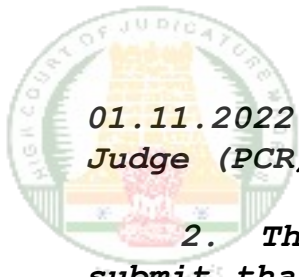
