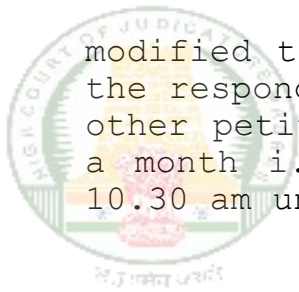
This Petition has been filed to relax the condition imposed in Crl.O.P(MD).No.20444 of 2022, dated 18.11.2022.
