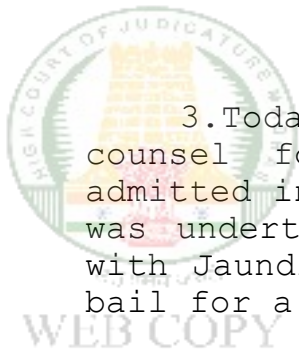
Prayer in CRL A(MD).613/2022 :

2.On 21.11.2022, this Court considering the health condition of the petitioner granted one month interim bail to him with certain conditions.
