PETITION FOR BAIL Under Sec.439 of Cr.P.C

PRAYER :-

For Bail in Cr.No.633 of 2022 on the file of the Respondent police.

ORDER : The Court made the following order :-

The petitioner/Accused, who was arrested and remanded to judicial custody on 10.12.2022, for the offences punishable under Sections 4(1) (a), 4(1-A) of Tamil Nadu Prohibition Act, in Crime No.633 of 2022, seeks bail.

2. The case of the prosecution is that the petitioner herein was illegally found in possession of 15 bottles (each contains 180 ml) of prohibited liquor. Hence, the complaint.

3.The learned counsel appearing for the petitioner submitted that the petitioner is innocent and he has not committed any offence, as alleged by the prosecution and he has been falsely implicated in this case. He further submitted that the petitioner is in judicial custody from 10.12.2022 and hence, prays for bail.



4. The learned Additional Public Prosecutor would submit that the petitioner is having 35 previous cases and the investigation of the case is pending and hence, prays to dismiss the petition.

5. Heard both sides and perused the materials on record. Taking into consideration of the facts and circumstances of the case and that there are 35 cases against the petitioner, this Court is not inclined to bail to the petitioner for the present.

6. Accordingly, this Criminal Original Petition is dismissed.
