Petition Under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ of mandamus or any other suitable writ or order declaring the action of the respondent in putting marks over the petitioner's plot admeasuring 111.11 sq.yards, bearing Plot No. 150, Sy.No. 343 & 344, Situated at Chillimalla (V) (Pebberr(M) Mahaboobnagar District, without initiating proceedings under law and without paying compensation as illegal arbitrary and contrary to principles of natural justice effecting right to life and property and consequently direct the respondents not to lay any road in plot No. 150, admeasuring 111.11 sq.yards, bearing Plot No. 150, Sy.No. 343 & 344, Situated at Chillimalla (V) (Pebberr(M) Mahaboobnagar District.

ORDER:

It is represented by the counsel for the petitioner that in pursuance of the interim order of this Court dated 23.09.2008 the respondents did not interfere in respect of petitioner's possession over the petitioner's plot admeasuring 111.11 sq. yards, bearing Plot No. 150, Sy.No. 343 and 344 situated at Chilimilla Village, Pebber Mandal, Mahaboobnagar District and that the petitioner also completed the construction of the house in the year 2008 and is in possession and enjoyment of the same.

2. The counsel for the petitioner submits that in view of the fact that there is no interference by the respondents in the petitioner's peaceful possession and petitioner's plot admeasuring 111.11 sq. yards, bearing Plot No. 150, no further orders are necessary.

3. The counsel for the petitioner further says that liberty shall be given to the petitioner to approach this Court in the even respondents interfere with petitioner's possession again. Under these circumstances, the Writ Petition is closed. There is no order as to costs.
