Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, to declare the action of the 1st respondent in including the petitioner's plot bearing No.28 in Sy.No. 123, admeasuring 220.00 Sq. Yds., situated at Chandanagar village, Serilingampally Mandal and Municipality, R.R.District, in the proposed auction to be conducted pursuant to the Sale Notice issued dt. 15-9-2013 proposing to conduct the auction of the land in Sy.No. 123/P admeasuring Ac. 0.25 Gts., situated at Chandanagar village, Serilingampally Mandal and Municipality, R.R.District, on 17-10-2013, as being illegal, arbitrary and unconstitutional and consequently direct the 1st respondent not to interfere with the peaceful possession of the petitioner in respect of the above said plot.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to pass orders directing the 1st respondent not to conduct the auction or in any manner interfere with the peaceful possession and enjoyment of the petitioner's Plot No.28, admeasuring 220.00 Sq. Yds., situated at Chandanagar village, Serilingampally Mandal and Municipality, R.R.District, pending disposal of the main Writ Petition.
