Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondent No. 2 herein, to consider documents filed by the petitioner herein pertaining to the property bearing No.30-220/12 on Plot No. 6 in survey Nos. 438 and 439 to extent of 266.66 Sq. yards or 222.92 Sq.mtrs situated at Old Safilguda, under Malkajigiri Municipality and Mandal, Malkajigiri-Medchal District favour of the petitioner Pending disposal of WP No. 34189 of 2022, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following.(The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

Learned counsel for the petitioners submits that in similar circumstances, this Court granted interim order in I.A.No.1 of 2020 in W.P.No.12086 of 2020 on 28.08.2020 and the same is not disputed by the learned Assistant Government Pleader for Revenue.

In view of the same, there shall be an interim direction to the respondent No.2 – Sub Registrar, Malkajgiri, to receive, process, register and release the documents submitted by the petitioners, if they are otherwise found to be in compliance with the provisions of Registration Act, 1908 and the Indian Stamp Act, 1899. However, registration of such documents shall be subject to the outcome of the present writ petition.

Registry shall make an endorsement on the writ petition to the effect that the same shall not be permitted to be withdrawn
