Learned counsel for petitioner/A1 seeks permission to withdraw the Criminal Petition.

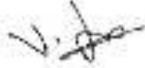
Permission is accorded and the Criminal Petition is dismissed as withdrawn. Miscellaneous applications, if any pending in this petition, shall stand dismissed.
