Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction, more in the nature of Writ of Mandamus declaring the in-action of the respondent No.3 in disposing off the appeal No. E/1656/2016 dated 01-06-2016 filed under 5-B of Telangana Rights in Land and, PPB Act, 1971 for setting aside of mutation proceedings and issuance of PPB/TD issued in favour of respondent No.5 with regard to land to an extent of Ac 3.32gts in Sy.No. 162/B/4 situated at Lingya Thanda H/o Kuravi village and, Mandal, Mahabubabad (Warangal) District is as being arbitrary, illegal and in violation of Article-14, 21 and 300-A of the Constitution of India inclusive of principles of natural justice and consequently direct the respondent No.3 to pass orders on appeal No. E/1656/2016 dated 01-06-2016 forthwith.
