ORDER :

Aggrieved by the judgment and decree dated 28-7-1999 passed in O.S.No.80 of 1996 by the III-Additional District Judge, Karimnagar, dismissing the suit filed by the plaintiff for declaration and for perpetual injunction restraining the defendants from interfering with his peaceful possession over the suit schedule well, this appeal is filed by the plaintiff against the defendants, who are Mandal Revenue Officer, Karimnagar and the District Collector, Karimnagar.
