In view of the above, the arbitration application is dismissed on withdrawal. No costs.

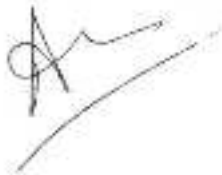
As a sequel, miscellaneous petitions, pending if any, stand dismissed.
