Petition under Section 437/438/439/482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to quash the proceedings in F.I.R. No.273 of 2020, dated 10.07.2020 on the file of the Shameerpet Police Station, for the alleged offences U/Sec.448, 427 r/w 34 IPC and to grant such other receipts and fee as the Hon'ble Court deems fit.

Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to grant stay of all further Proceedings in F.I.R. CRIMINAL PETITION No.3068 of 2020

ORDER:

This Criminal Petition is filed seeking quashment of proceedings in Cr.No.273 of 2020 of P.S.Shameerpet, registered for the offences under Sections 448, 427 read with Section 34 of Indian Penal Code, against the petitioners/accused.

02. Learned Assistant Public Prosecutor submitted a letter dated 01-09-2022 addressed by the Sub-Inspector of Police, Shameerpet P.S., wherein it is stated that investigation is completed and charge sheet has been filed before learned XXIII Metropolitan Magistrate, Medchal and the same has been numbered as C.C.No.1709 of 2021.

03. The same is recorded.

04. In view of the above submission, since the very purpose of filing this Criminal Petition is already been

defeated, no purpose would survive to proceed with this Criminal Petition and the same has become infructuous.

05. In view of the above, this Criminal Petition is liable to be dismissed.

06. Accordingly, this Criminal Petition is dismissed as infructuous. There is no order as to costs.
