Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any appropriate writ, order or direction one more particularly one in the nature of Writ of Mandamus

i) declaring the inclusion of Petitioners lands in Memo No. G1/2263 of 2014 dated 25-09-2014 sent Respondent No.3 to respondent No.6 as unlawful, unconstitutional and violative of petitioners constitutional rights and set aside such inclusion

ii) Declare the said Memo No. G1/2263 of 2014 dated 25-09-2014 in so far as the petitioner's lands as ultravires endowment Act, Registration Act apart from being unconstitutional and strike down the said Memo No. G1/2263 of 2014 dated 25/09/2014.

iii) Declare the action of respondent No.6 in taking note of such illegal communication sent by respondent No. 3 and thereby not registering and releasing the documents presented by the petitioners relating to the land presented by the petitioners in respect of land in Sy No.214/Part to an extent of Ac.0-04,132 guntas situated at Davaryamjal Village, Shameerpet Mandal, Medchal-Malkajgiri District as illegal, arbitrary, unconstitutional, ultra-vires Registration Act and set aside such action ;

iv) Resultantly direct the respondent No.6 to forthwith register and release the sale deed which was presented by the petitioners and direct the respondents not to interfere with the petitioners rights in any manner

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to forthwith register and release the document which was presented by the Petitioners pertaining to the land in Sy No.214/Part to an extent of Ac.0-04,132 guntas situated at Davaryamjal Village, Shameerpet Mandal, Medchal-Malkajgiri District without reference to the communication of the 3rd respondent issued vide Memo No. G1/2263 of 2014 dated 25-09-2014 pending disposal of the writ petition

WRIT PETITION No.11606 of 2021

ORDER:

Learned counsel for the petitioners filed a letter dated 26.12.2022 in the Registry seeking permission of this Court to withdraw the writ petition with liberty to the petitioners to file a fresh writ petition.

2. This Court by an order dated 29.04.2021 granted interim direction as prayed for in I.A.No.1of 2021 in W.P.No.11606 of 2021. However, this Court made it clear that any registration pursuant to the said interim order is only a provisional one and the same is subject to the final result of writ petition; and that the petitioners shall not claim any equities in the event any adverse orders are passed against them and no equities would accrue to the purchasers.

3. In view of the fact that since the petitioners are seeking permission of this Court to withdraw the writ petition, any registration that had taken place in respect to the subject property after order, dated 29.04.2021 passed by this Court, shall stand cancelled and respondent No.6 shall take necessary consequential steps.

4. Accordingly, this Writ Petition is dismissed as withdrawn granting liberty as sought for by the petitioners. There shall be no order as to costs.

Miscellaneous applications, if any, pending in this writ petition, shall stand closed.
