Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, to declare the inaction of the 2nd respondent herein in taking steps to correct the survey number in the new pattadar pass book and in the Dharani Portal as Sy.No. 427/A in the place of A/2 admeasuring Ac. 0.12 gts., inspite of the written representation dt. 27-1-2022 followed by personal visits, as being illegal, arbitrary and unjust and consequently direct the respondent authorities to correct the mistake with regard to the survey number as Sy.No. 427/A in the place of "A/2" in the newly issued pattadar pass book and Dharani Portal.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondent authorities to consider and take appropriate action immediately pursuant to the written representation dt. 27-1-2022, pending disposal of the main Writ Petition.

WRIT PETITION No.15800 of 2022

ORDER:

Heard learned counsel for the petitioner and learned Assistant Government Pleader for Revenue appearing for the respondents. The writ petition is disposed of at the stage of admission.

2. The case of the petitioner is that he is the absolute owner and possessor of land admeasuring Ac.0.12 guntas in Survey No.427/A situated at Peddalingapuram Village, Ellanthakunta Mandal, Rajanna Sircilla District. His name was mutated in the revenue records and he was issued pattadar passbook and title deeds and he has been in peaceful possession and enjoyment of the same. The grievance of the petitioner is that though his name was mutated in the revenue records, the survey number is wrongly mentioned as 'A/2' instead of 'Survey No.427/A' and in spite of making repeated representations, the respondents are not taking any action.

3. When the matter is taken up for consideration, learned Assistant Government Pleader for Revenue submitted that earlier there was no option for correcting the errors in Dharani Portal and the said survey number was wrongly mentioned as 'A/2' instead of 'Survey No.427/A' by mistake. He further submitted

that the module is now available in Dharani Portal and if the petitioner makes an application seeking correction of survey number in the revenue records, the respondents would consider and dispose of the same in accordance with law.

4. Learned counsel for the petitioner submitted that after filing of this writ petition, the petitioner submitted an online application bearing No.2200061149, dated 02.07.2022, and the same is pending consideration before respondent No.2.

5. In the light of the submissions made on either side, the writ petition is disposed of directing respondent No.2 to consider the online application bearing No.2200061149, dated 02.07.2022, seeking correction of the survey number as 'Survey No.427/A' instead of 'A/2' in respect of land admeasuring Ac.0.12 guntas situated at Peddalingapuram Village, Ellanthakunta Mandal, Rajanna Sircilla District, in the name of the petitioner and pass appropriate orders in accordance with law, within a period of four weeks from the date of receipt of a copy of this order. There shall be no order as to costs.

Miscellaneous Petitions, if any, pending in this writ petition shall stand closed.
