Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ of mandamus or any other appropriate writ, order or direction declaring the allotment of the Petitioner to the Kamareddy District Local Cadre by the Respondents vide orders bearing Proc. No. ES/ES/NI/KAMA/SEGR/3166 dt.20/2/2021 and Proc. No.ES/SC/KAMA/SEGR/0252 dt. 07/01/2022 as being illegal, arbitrary, unconstitutional, in violation of the principles of natural justice and in violation of Articles 14 and 21 of the Constitution of India and consequently to set aside the same and direct the Respondents to allot the Petitioner to a school in the Nizamabad District Local Cadre.

ORDER:

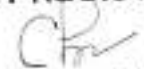
Heard the learned counsel for the petitioner, learned Assistant Government Pleader for Services-I, and perused the material on record.
