JUDGMENT:

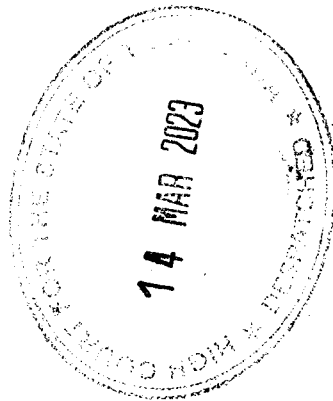
