These Appeals coming on for hearing and upon perusing the grounds of appeals the Judgment and Decree of the Lower Court and the material papers in the case and upon hearing the arguments of Sri Kasi Reddy Jagathpal Reddy, Advocate for the Appellant in MACMA.No.3 of 2014 and Respondent in MACMA.No.3193 of 2014 and of Sri Thoom Srinivas, SC for TSRTC for the Respondents in MACMA.No.3 of 2014 and Appellants in MACMA.No.3193 of 2014.

This Court doth Order and Decree as follows:

1. That the Motor Accident Civil Miscellaneous Appeal No.3 of 2014 filed by the claimants allowed in part and MACMA.No.3193 of 2014 filed by Road Transport Corporation is dismissed.
2. That the compensation amount awarded by the tribunal be and hereby is enhanced from Rs.2,74,000/- to Rs.5,33,200/- (Rupees five lakhs thirty three thousand two hundred only)
3. That the enhanced amount shall carry interest at 7.5% p.a. from the date of filing of the O.P. till the date of realization.
4. That the respondents be and hereby are directed to deposit the said amount within two months from the date of receipt of a copy of this Judgment.
5. That on such deposit the claimants be and hereby is permitted to withdraw entire compensation amount
6. That the claimant be and hereby is directed to pay deficit court fee on the enhanced amount.
7. That save as aforesaid, the decree of the lower court do stands confirmed in all other respects; and
8. That there shall be no order as to costs in these Appeals.
