The petitioners/A-2 &amp; A-3 are directed to surrender before the Station House Officer, Khammam II Town Police Station, within ten days from the date of this order, and on such surrender, they are directed to be released on bail on their executing a personal bond to the tune of Rs.10,000/- (Rupees Ten Thousand Only) each with two sureties to the like sum each to his satisfaction.</p> <p>7(2). The petitioners/A-2 &amp; A-3 shall abide by the other conditions stipulated in Section 438(2) Cr.P.C., and co-operate with the Investigating Officer in investigating the case as and when required.</p> <p>7(3).
