Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an order of direction or writ in the nature of Mandamus duly declaring the action of the respondents in trying to evict the petitioner from his patta lands vide an extent of Acres 3.24 guntas in survey numbers 107/31/7/1, and 107/31/8/4, situated at Yanambailu Village of Palvancah Mandal, Bhadradi Kothagudem District without any notice or proceedings as illegal, arbitrary and against the principles of natural justice and consequently direct the respondents not to interfere with the peaceful possession and enjoyment of the above lands in the interest of justice.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents not to interfere with the petitioner's peaceful possession and enjoyment of the lands vide an extent of Acres 3.24 guntas in survey numbers 107/31/7/1, 85 107/31/8/4, situated at Yanambailu Village of Palvancha Mandal, Bhadravadi Kothagudem District in the interest of justice.

WRIT PETITION No.25414 of 2022

ORDER:

This Writ Petition is filed seeking to declare the action of the respondents in trying to evict the petitioner from his patta land to an extent of Ac.3-24 guntas in Survey Nos.107/31/7/1 & 107/31/8/4, situated at Yanambailu Village, Palvancha Mandal, Bhadrachalam District, without issuing any notice or proceedings as illegal, arbitrary and consequently to direct the respondents not to interfere with the peaceful possession and enjoyment of the petitioner over the subject land.

2. Heard learned counsel for the petitioner and learned Assistant Government Pleader for Revenue appearing for the official respondents.

3. Learned Assistant Government Pleader for Revenue placed before this Court the written instructions received from the respondents. From the said written instructions, it is seen that as per the instructions of respondent No.2, the Mandal Surveyor, from the office of the 4th respondent, and Mandal Girdawar-II have demarcated the Government land for the purpose of establishing

Telangana Gram Kreedha Pranganam. The respondents are no way interfering with the patta land of the petitioner.

4. In the light of the said written instructions, there is no necessity to further examine the matter in detail and accordingly, the Writ Petition is disposed of directing the respondents not to interfere with the patta land of the petitioner admeasuring Ac.3-34 guntas in Survey Nos.107/31/7/1 and 107/31/8/4, situated at Yanambailul Village of Palvancha Mandal, Bhadradi Kothagudem, in any manner.

Miscellaneous petitions, pending if any, shall stand closed.

There shall be no order as to costs.
