Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or a direction, more particularly of Writ of Mandamus directing the respondents to consider the station given to the Respondents on 21.03.2022 for stopping the drainage outflow into the Petitioners land and also not to interfere into petitioners peaceful possession without due process of law in respect of the Petitioners land consisting of Ac 2.30 gts of land situated at Gorantlagunta Village, Gisugonda Mandal, Warangal Rural District, Telangana, and also declare the action of respondents in not considering my representation as arbitrary, unjust and violative of Article 14, 21 and 300-A of the Constitution of India.

ORDER:

Heard the learned counsel for the petitioner, the learned Government Pleader for Municipal Administration and Urban Development for respondent No.1 and Ms.Pingali Lakshmi, learned Standing Counsel for respondents 2 to 4. With their consent, the Writ Petition is disposed of at the stage of admission.

Seeking to direct the respondents to consider the representation dated 21.03.2022 submitted by the petitioner complaining about the drainage water being diverted into his patta land situated at Gorantlagunta Village, Geesugonda Mandal, Warangal Rural District, the present Writ Petition is filed.

Having regard to the fact that the representation of the petitioner is already pending before respondent No.2 for consideration, without going into the merits or demerits of the case, the Writ Petition is disposed of directing the respondent No.2 to consider the representation made by the petitioner on 21.03.2022 and pass necessary orders thereon, strictly in accordance with law, as expeditiously as possible, preferably,

within a period of four weeks from the date of receipt of a copy of this order. A copy of the order likely to be passed by the respondent No.2 shall be communicated to the petitioner.

The miscellaneous petitions pending, if any, shall stand closed. There shall be no order as to costs.
