Petition Under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, order direction particularly one in the nature of WRIT OF MANDAMUS Declaring the action of the Respondent No.3 in calling the petitioner through Mr Nandakumar to attend before them in respect of FIR No. 341/2022 on the pretext of questioning without even naming him in the said FIR at the behest of Respondent No.4 and his family members as illegal, improper, arbitrary, unreasonable and violative of principles of natural justice and consequentially direct the Respondent No.3 not to summon petitioner to Police station in respect of FIR No.341/2022 dated 26-5-2022 at, the behest of Respondent No.4.

ORDER:

Questioning the action of the respondent No.3 in calling the petitioner through Mr. Nandakumar to attend before them in respect of FIR.No.341 of 2022 on the pretext of questioning without even naming him in the said FIR at the behest of the respondent No.4 and his family members, the petitioner has filed the present Writ Petition.

When the matter is taken up, the learned Government Pleader for Home, on the basis of the written instructions issued by the Sub-Inspector of Police, Patancheru Police Station, Sanga Reddy, has stated that based on the allegations made by A.1 in Crime No.341 of 2022, the name of the petitioner has also been added and necessary investigation is in progress.

Having regard to the above, the prayer sought by the petitioner cannot be granted.

Accordingly, this Writ Petition is disposed of.
