CRIMINAL PETITION No.5300 OF 2022

ORDER:

This Criminal Petition under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.'), is filed seeking to quash the proceedings in C.C.No.348 of 2022, pending on the file of II AJCJ-Cum-X Additional Metropolitan Courts, Kukatpally, Ranga Reddy District. The petitioners herein are accused Nos.4 and 5 in the said crime. The offences alleged against them are under Sections 498-A of IPC and Sections 3 and 4 of Dowry Prohibition Act, 1961.

2. Heard the learned counsel for the petitioners and learned Assistant Public Prosecutor for the respondent-State. Perused the record.

3. As per the contents of the charge sheet in C.C.No.348 of 2022, the marriage of A-1 with the 2nd respondent was performed on 24.10.2013. Thereafter, matrimonial disputes arose between them. Accused No.1 filed HMOP No.142 of 2016 on the ground of cruelty and the same is pending. The petitioners herein are maternal Uncle and Aunt of A-1. In matrimonial disputes, identification of parties

is not in dispute. The punishment prescribed for the offences alleged against the petitioners herein is below seven years.

4. In view of the above discussion, this Criminal Petition is disposed of dispensing with the presence of the petitioners herein/A-4 and A-5 in C.C.No.348 of 2022, pending on the file of II AJCJ-Cum-X Additional Metropolitan Courts, Kukatpally, Ranga Reddy District. However, they shall appear before the said Court as and when their presence is required.

Miscellaneous Petitions, if any, pending, shall also stand closed.
