Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order, direction or Writ more particularly one in the nature of Writ of Mandamus or any other appropriate writ to declare the action of the Respondents in not conducting the survey of the Petitioner's land admeasuring Ac.4-31gts. in Sy. Nos. 102/E, situated at Govindapur Village, Zaheerabad Mandal, Sangareddy District, in terms of the provisions of the Andhra Pradesh Survey and Boundaries Act, 1923, as adopted in the State of Telangana, as illegal, arbitrary and unjust and consequently direct the Respondents herein to conduct the survey of the Petitioner's land admeasuring Ac.4- 31gts. in Sy. Nos. 102/E, situated at Govindapur Village, Zaheerabad Mandal, Sangareddy District, in pursuance of his survey application No. DER022200752813, dated 17-02-2022

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents herein to consider the representation of the Petitioner dated 17/06/2022 and also to direct the Respondents to complete the survey of the Petitioner's land admeasuring Ac.4-31gts. in Sy. Nos. 102/E, situated at Govindapur Village, Zaheerabad Mandal, Sangareddy District by fixing the prescribed period of time

The Court made the following: ORDER

assistance of police, the villagers have been objecting for conducting of survey that is initiated pursuant to the application of the petitioner and the same could not be completed.

5. Taking into consideration the submissions made on either side, this Court is of the view that the respondents, having received the application of the petitioner and having initiated process for conducting survey pursuant to the said application, there is no justification for the respondents to postpone the same indefinitely on the ground that the villagers are objecting, as the petitioner is seeking survey of the land belonging to him but not the land belonging to third parties. For conducting any survey, they are entitled to submit their objections and the respondents are entitled to take into consideration the said objections and conclude the proceedings initiated pursuant to the application submitted by the petitioner.

6. Hence, this Writ Petition is disposed of directing the respondents 4 and 5 to conclude the proceedings of conducting survey pursuant to the F-line application submitted by the petitioner vide No.DER022200752813 dated 17.02.2022 and pass appropriate orders therein within a period of six (6) weeks from the date of receipt of a copy of this order.

There shall be no order as to costs. Miscellaneous applications, if any, pending shall stand closed.
