ORDER:

This Writ Petition is filed seeking a writ of Mandamus to declare the action of the respondents in allotting the petitioner to Jagtial District vide proceedings No.ES/SC/KA/JAGI/LAPA/0008, dated 23.12.2021 as illegal, arbitrary and violating Articles 14 and 16 of the Constitution of India and also to declare the action of the respondents in not considering the applications of the petitioner dated 07.01.2022 and 12.01.2022 is illegal and arbitrary.

2. The case of the petitioner in brief is that she was allotted to Jagtial District as per proceedings No.ES/SC/KA/JAGI/LAPA/0008, dated 23.12.2021. As per G.O.Ms.No. 317 dated 06.12.2021 certain guidelines were issued and as per the said guidelines the petitioner submitted applications on 07.01.2022 and again on 12.01.2022 on spouse grounds for change of her local cadre to Karimnagar District.

3. The learned Government Pleader for Services confirmed that the petitioner has made appeal in the prescribed format.

4. In view thereof, the respondents No.1 and 2 are directed to dispose of the appeals of the petitioner within a period of 4 weeks from the date of receipt of a copy of this order.

4. Writ petition is accordingly disposed of. However, no order as to costs.

5. Miscellaneous applications, if any pending, shall also stand closed.
