I Town Police Station, Siddipet in crime No. 130 of 2022 on such terms,
otherwise the Petitioners/Accused No. 3 shall be put to great irreparable
loss and injury.

This Petition coming on for hearing, upon perusing the Memorandum
of Grounds of Criminal Petition and upon hearing the arguments of Sri M.
V. Raj Kumar Gabriel, Advocate for the Petitioner and the Assistant Public
Prosecutor on behalf of the Respondent.

The Court made the following: ORDER

THE HONOURABLE SRI JUSTICE K.SURENDER**CRIMINAL PETITION No.6497 OF 2022****ORDER:**

This Criminal Petition is filed under Section 438 of the Code of Criminal Procedure, 1973 seeking pre-arrest bail to the petitioner, who are arrayed as Accused No.3 in the event of his arrest in Crime No.130 of 2022 on the file of Station House Officer, 1-Town Police Station Siddipet, registered for the offences punishable under Section 304-B r/w.34 of Indian Penal Code.

2. Heard the learned counsel for the petitioner and learned Assistant Public Prosecutor for the respondent-State. Perused the record.

3. Learned counsel for the petitioner submitted that the investigation is completed and charge sheet is already filed.

4. Learned Assistant Public Prosecutor submitted that the petitioner was said to be absconding and the Police had sought

for non-bailable warrant from concerned Court and no such warrants are issued.

5. Under the circumstances, there are no warrants pending, there is no apprehension of arrest to the petitioner. However, keeping in view the petitioner has to attend for the proceedings before the trial Court, the petitioner shall be surrendered before the learned Prl. Judicial First Class Magistrate, Siddipet and on such surrender, he shall be enlarged on bail on his executing personal bonds for a sum of Rs.25,000/- (Rupees Twenty Five Thousand Only) with two sureties to the like sum each, to its satisfaction.

6. Accordingly, the Criminal Petition is disposed off.

7. Miscellaneous applications pending, if any, in this criminal petition, shall stand closed.
