This Criminal Petition is filed under Section 482 of Code of Criminal Procedure, 1973 (for short "Cr.P.C") seeking to quash the proceedings against the petitioner-Accused No.5 in Crime.No.108 of 2017 on the file of the Chief Metropolitan Magistrate, Nampally, Hyderabad. The offences registered are under Section 354-A, 420, 506 and Sec.7 of the Drug and Black Magic Remedies Act, 1954 read with 34 of IPC.
