ORDER :

Seeking to quash the proceedings that are pending against the petitioner in Crime No.609 of 2021 of Jubilee Hills Police Station, Hyderabad District, the present Criminal Petition is filed.

2. No representation on petitioner's side on call. However, the learned Assistant Public Prosecutor on written instructions submits that on completion of investigation, charge sheet is laid and, hence, the Criminal Petition has become infructuous.

3. Recording the said submission, this Criminal Petition is dismissed, however, granting liberty to the petitioner to move a fresh Criminal Petition, in case the cause survives.

4. As a sequel, miscellaneous petitions pending, if any, shall stand closed.
