Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or order more particularly one in the nature of writ of mandamus or any other appropriate writ or order or orders declaring action of Respondents in trying to erect 500 KV electricity transformer in front of the house of the petitioner situated at Ward No.4 Block No.2, Cinema Road, Adilabad occupying 30 feet road, despite having sufficient places as being arbitrary, vindictive, illegal, violative of Articles 14, 16 and 21 of the Constitution of India and against to the principles of Natural Justice, and consequently direct the Respondents not to erect 500 KV electricity transformer in front of the house of the petitioner, situated at Ward No.4 Block No.2, Cinema Road, Adilabad occupying the road.
