This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioner-Accused No.2 seeking to quash the proceedings against him in CC No.753 of 2019 on the file of XV Additional Chief Metropolitan Magistrate at Nampally, Hyderabad which arose out of Crime No.166 of 2018 of Women Police Station, Charminar, Hyderabad.
