

**THE HONOURABLE SRI JUSTICE K. SURENDER****CRIMINAL PETITION No.9404 OF 2021**  
**ALONG WITH I.A.NO.2 OF 2021****COMMON ORDER:**

This Criminal Petition is filed under Section 482 Cr.P.C., to call for the records pertaining to Cr.No.58/2021, Ramannapet P.S., Rachakonda District and to quash the same.

2. During the pendency of the present Criminal Petition, the petitioners and the 2<sup>nd</sup> respondent have entered into compromise and the 2<sup>nd</sup> respondent has filed IA.No.2 of 2021 to record the terms of compromise and to compound the offences.

3. Vide order dated 09.03.2022, this Court, after recording the submissions made by the learned counsel for the petitioners as well as respondent No.2, directed the parties to appear before the Secretary, Telangana High Court Legal Services Committee, Hyderabad, for their identification on or before 16.03.2022 and also directed the Secretary to submit a report by 16.03.2022. In compliance with the said order, the Secretary has submitted his report, on 16.03.2022.

4. In the report of the Secretary, Telangana High Court Legal Services Committee, Hyderabad, it is stated that in obedience of the orders dated 09.03.2022, the petitioners and the 2<sup>nd</sup> respondent have appeared before him along with their counsel and on examination and verification of their particulars from their Aadhar Cards, they were tallied. Thus the identification of both the parties has been established.

5. The parties herein have filed a joint memo of compromise stating that at the intervention of the elders, they have settled the disputes between them amicably and 2<sup>nd</sup> respondent has no objection to quash the proceedings against the petitioners/accused Nos.1 to 5 in Cr.No.58/2021. The said joint memo of compromise and the report of the Secretary are placed on record.

6. In view the said report of the Secretary, Telangana High Court Legal Services Committee, Hyderabad, and also in view of the compromise entered between the petitioners and respondent No.2, I.A.No. 2 of 2021 is allowed. Consequently, the Criminal Petition is allowed and the proceedings against the

petitioners/accused Nos.1 to 5 in Crime No.58/2021 on the file of P.S.Ramannapet, Rachakonda District are hereby quashed.

7. As a sequel, the miscellaneous Petitions, pending if any, shall stand closed.
