Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or order or direction more particularly in the nature of Writ of Mandamus declaring the action of the respondent in issuing the impugned proceedings No.APTDC/Admn/P1/84/2010 dated 26-3-2011 in not considering case of the petitioner for promotion to the post of Deputy Manager is illegal, arbitrary and violation of principles of natural justice and setaside the same and consequently direct the respondent to consider the case of petitioner for promotion to the post of Deputy Manager in the existing vacancies by considering the petitioner representations dated 18-5-2011, 7-9-2011, 18-6-2012 and 13-2-2013

ORDER:

This Writ Petition is filed seeking a Writ of Mandamus declaring the action of the respondent in issuing the impugned proceedings No.APTDC/Admn/P1/84/2010, dated 26.03.2011 in not considering case of the petitioner for promotion to the post of Deputy Manager as illegal and arbitrary, to set aside the same and consequently, to direct the respondent to consider the case of the petitioner for promotion to the post of Deputy Manager in the existing vacancies by considering the petitioner representations dated 18.05.2011, 07.09.2011, 18.06.2012 and 13.02.2013 and pass such orders which this Court deems fit and just.

2. Learned counsel for the petitioner submits that consequent to the interim direction given by this Court dated 02.04.2013 in W.P.M.P.No.10053 of 2013 the case of the petitioner was considered and he was promoted accordingly and therefore, no further orders are necessary.

3. Recording the said submission, the writ petition is closed. There shall be no order as to costs.

4. Miscellaneous applications, pending if any, shall stand closed.
