Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the Respondents in not releasing the power supply to the Petitioners buildings at premises bearing Land admeasuring 738.02 sq yards of A-Schedule and B-Schedule, H.No.8-2-618/6, 8-2-618/6/K, covered by Sy.No.129/70, Situated at Road No.11, Banjara Hills, Shaikpet Village, Hyderabad, as illegal, null, void, arbitrary and consequently direct the respondents to release the power supply without insisting for occupancy certificate;
