Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to stay of all further proceedings including arrest of the Petitioners Accused No. 2 and 3 in FIR No.529 of 2022 dated 28-11-2022 on the file of PS Khammam 2 town, for the offences under Sections 498-A, 354, 420, 506 r/w 34 of I.P.C and Section 3 and 4 of DP Act.

This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri A Samir Kumar Reddy, Advocate for the Petitioner and the Public Prosecutor on behalf of the Respondent No. 1 and none appeared for the Respondent No. 2

The Court made the following: ORDER

THE HONOURABLE SRI JUSTICE K.SURENDER**CRIMINAL PETITION No.11123 OF 2022****ORDER:**

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioners-Accused Nos.2 and 3 to quash the proceedings against them in FIR No.529 of 2022 pending on the file of Station House Officer, Khammam II Town Police Station, Khammam District, registered for the offences punishable under Sections 498-A, 354, 420 and 506 read with Section 34 of Indian Penal Code (for short "IPC") and Sections 3 and 4 of Dowry Prohibition Act (for short "DP Act").

2. Heard learned counsel for the petitioners – Accused Nos.2 and 3 and learned Additional Public Prosecutor for the respondent – State. Perused the material on record.

3. Since the complaint is on account of marital disputes in between the Accused No.1 and the 2nd respondent, this Court deems this appropriate to direct the Investigating Officer in FIR No.529 of 2022 pending on the file of Station House Officer, Khammam II Town Police Station, Khammam District, to conclude

the investigation without taking any coercive steps against the petitioners-Accused Nos.2 and 3. Further, the petitioners shall co-operate with the Investigating Officer as and when required for the purpose of investigation.

4. Accordingly, the Criminal Petition is disposed off.

Miscellaneous applications pending, if any, shall stand closed.

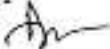
