Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or order or direction one more particularly in the nature of Writ of Mandamus' declaring the action of the respondents 2 to 4 in not considering the Dharani Online Application No.LM22000-34305. dated 27.7.2022 submitted by the petitioner requesting to issue E-Pattadar Pass Book in his favour in respect of agriculture land in Sy.No.578/3 to an extent of Ac 4.26gts situated at Sudeemalla village, Yellandu Mandal, Bhadradi Kothagudem District as illegal, arbitrary, violative of principles of natural justice and also contrary to the provisions of Telangana Rights in Land and Pattadar Pass Book Act, 2020 and consequently direct the respondents to consider the Dharani Application No.LM2200034305 of the petitioner for issuance of E-Pattadar Pass books in respect of aforesaid land of the petitioner;
