Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of writ of mandamus, declaring the action of the Respondents No. 2 to 4 in interfering with peaceful possession of the property bearing Plot 337, Type-B, in Sy. No. 75, admeasuring 300 sq. yards, or 250.80 sq.mts., situated at Kondapur Village, Serilingampally Mandal and Municipality, Rangareddy District is illegal, arbitrary and against the principles of natural justice and the law laid down by the Hon'ble Supreme Court;

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents No. 2 to 4 not to interfere in the petitioner's peaceful possession of the property bearing Plot 337, Type-B, in Sy. No. 75, admeasuring 300 sq. yards, or 250.80 sq.mts., situated at Kondapur Village, Serilingampally Mandal and Municipality, Rangareddy District, pending disposal of the main writ petition;

WRIT PETITION No.45873 OF 2022

ORDER: (ORAL)

This writ petition is filed aggrieved by the action of the respondent Nos.2 to 4 in interfering with the peaceful possession of the property bearing Plot No.337, Type-B, admeasuring 300 sq. yards or 250.80 sq. meters, situated at Kondapur Village, Serilingampally Mandal and Municipality, Ranga Reddy District.

2. Heard the learned counsel for the petitioner and the learned Assistant Government Pleader for Home, and perused the material available on record.

3. Based on the written instructions dated 28.12.2022 issued by the Sub-Inspector of Police, Gachibowli Police Station, Cyberabad Commissionerate, the learned Assistant Government Pleader submitted that respondent No.2 is no way concerned with the subject property. As on today, no one has lodged a complaint against the petitioner and there is no crime registered in the police station of respondent No.2. Further, it is stated that respondent No.2 never interfered in the civil disputes of the petitioner over the subject property.

4. Learned counsel for the petitioner submits that in view of the statement of respondent No.2 that there is no crime registered against the petitioner and there is no interference from the police in any manner, appropriate orders be passed.

5. In view of the above, the writ petition is closed. If the petitioner has any further grievance, he is at liberty to approach this Court at later point of time.

As a sequel thereto, miscellaneous applications if any, pending in the writ petition stand closed. No order as to costs.
