Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly, one in the nature of Writ of Mandamus, declaring the action of the 2nd and 4th respondents in not taking action as per the Assignment Rules and initiating the proceedings under the provisions of the Telangana Assigned Lands (Prohibition of Transfer) Act, 1977 by evicting the 6th respondent from the land of the petitioner and restore the possession of land to an extent of Ac.0-15 Gts. in Sy.No. 313/2/2, situated at Mustafanagar Village, Gambhiraopet Mandal, Rajanna-Siricilla District to the petitioner, as illegal, arbitrary, unconstitutional, against the principles of natural justice and in contrary to the provisions of the Telangana Assigned Lands (Prohibition of Transfers) Act, 1977 and the Rules made there under, in the interests of justice;

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the 4th respondent to initiate action by issuing notice u/s. 4 of the Telangana Assigned Lands (Prohibition of Transfer) Act, 1977, pending disposal of Writ Petition;
